Who can apply:

Law students either of Five years or Three years degree course are eligible to apply for this program.

Skills required:

Efficiency in written Communication (English), Legal writing, Basic legal knowledge, Computer Operation in Word/Excel/PPT.

Timeline:

18th August, 2025 (Till 5:00 PM)

Last date for submission of applications. Application should be submitted with passport size photograph of the applicant alongwith scanned copy of

recommendation letter issued by Principal/HOD of Law Department. In case desired documents are not attached, then application will not be considered.

22nd August, 2025

Students will be selected by following appropriate criteria, if more than required applications are received. The shortlisted students will be informed about the same via e-mail.

25th August, 2025 (Last Date for sending confirmation)

Students shall be required to send a confirmation e-mail @ legallitwing-dslsa@nic.in of their participation in Internship Program positively latest by 25^{th} August, 2025, failing which their application is liable to be rejected.
